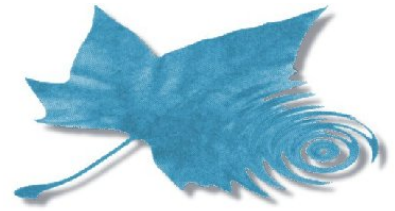

Bequests

A bequest is a gift made in a will, reserving part of an estate for a particular beneficiary. The bequest may be given for use at the discretion of the Palliative Care Council, which gives the greatest flexibility, or can be directed to a specific project.

If you have an existing will, but wish to add a bequest to it, this can be done by adding a codicil to the will. (Example given below, with suggested wording.) This form should be sent to your solicitor.
